ABSTRACT: *Critical Discourse Analysis (CDA) is used in this paper to examine how The Beatles' "Till There Was You" lyrics create a specific vision of romantic love and its possible transformation power. Though usually associated with The Beatles, Meredith Willson wrote the song for the 1957 Broadway musical *The Music Man*. Before Willson changed both its title and arrangement for theatrical inclusion, earlier iterations of the work were performed under the title "Till I Met You," first by Eileen Wilson in 1950 and then by Fran Warren in 1951 (Laird, 2008).

Produced by George Martin and recorded at Abbey Road Studios in July 1963, The Beatles' adaptation was first published on their second UK album *With the Beatles* and subsequently played for American audiences via *Meet the Beatles!* in 1964. Ringo Starr's bolero-style bongos enhanced George Harrison and John Lennon's delicate and passionate vocals over a Spanish-influenced acoustic guitar line (Rodriguez, 2012). Their interpretation stayed loyal to the romantic core of the song while adding a new degree of sophistication by combining pop and classical elements. This artistic blending fit the changing musical direction of the ensemble.

Though often disregarded in certain fan retrospectives, "Till There Was You" was crucial in forming The Beatles' early character. Including this Broadway piece proved their musical variety and would appeal to more conventional listeners during their failed Decca Records test. Spizer (2000) claims that this calculated

move set them apart from other Merseybeat groups and prepared them for their ultimate deal with Parlophone—a turning point in their worldwide career.

Linguistically, "Till There Was You" is a fascinating topic for Critical Discourse Analysis (CDA), a methodological lens used to investigate how language both reflects and shapes social ideas, relationships, and conventions (Machin & Mayr, 2012). Though apparently straightforward, the words of the song have great symbolic value and show love as an agent of inner transformation—a notion one might define as a kind of "linguistic awakening."

The narrator's change in consciousness is shown by the frequent use of denial (e.g., "never heard them at all," temporal contrast ("Till there was you,"), and strong sensory imagery ("bells on the hill," "birds in the sky"). These characteristics best capture what Charteris-Black (2011) describes as "semantic framing," in which language emphasizes certain experience factors to help to influence perspective. Love is shown in this song not just as a feeling but also as a catalyst revealing a universe before unseen.

Moreover, the song supports cultural values of mid-20th century about love and gender roles. Inspired by the silence of a love partner, the speaker's metamorphosis reflects postwar stories in which female characters are often presented as inert yet essential to masculine self-realization (Burns, 2020). Reflecting the societal mores of the day, this dynamic gently supports conventional gender roles. Using a CDA perspective helps one to see how music, even in its lightest tones, contributes to more general cultural dialogues. As Gee (2014) contends, media's language not only reflects but also creates social identities and power systems. Under these circumstances, "Till There Was You" becomes more than just a love song; it's a text encouraging the idealization of romantic love as a road to emotional depth and self-awareness.

The Beatles's performance of "Till There Was You" embodies more than simply musical brilliance. Underneath its classical compositions and lyrical simplicity is a larger conversation about gender, change, and the force of emotional connection. By use of critical discourse analysis, the song may be valued not just for its musical quality but also for its cultural and ideological connotations, therefore rendering it a timeless illustration of how language in music could resound well beyond the words themselves.

II. METHODOLOGY

This qualitative study uses Critical Discourse Analysis (CDA) which involves the following steps: First, data collection and text selection are conducted. The selected text is the song "Till There Was You" by The Beatles. The lyrics are transcribed, focusing on specific words and phrases. The text then undergoes a close reading and is segmented into "before" and "after" sections to highlight the contrast in the narrative.

Second, data analysis is performed. This step examines word choices (lexicon), sentence structure (grammar), deeper meanings (semantics), figurative language, and discourse markers. Attention is given to the shift from negative to positive language. Through these analyses, the study seeks to understand how these linguistic elements construct the representation of love and transformation using CDA techniques.

Third, interpretation takes place. The meaning of the linguistic features related to love and transformation is explained. Patterns are identified, underlying values are inferred, and the study explains how the language constructs the song's specific representation of these concepts, considering the potential cultural context in which the song was created. Finally, conclusions are drawn. This step summarizes the key interpretations regarding the song's construction of meaning, the power relations involved, and its social contexts.

III. ANALYSIS AND DISCUSSION

The tables provide an analysis of speaker's before and after, s of the specific words and phrases paint a picture of the speaker's before and after, which refers to the emotional and sensory tones created by the language; thus, called "linguistic colors"

Often referred to as linguistic color, "Till There Was You" communicates emotional and sensory tones via the song's narrative lyrics.

Rich sensory pleasures abound in the "after," ("music," "wonderful roses," "sweet fragrant meadows"). The speaker emphasizes the great influence of the person they discuss by moving from a condition of emotional emptiness to one full with affection. The way language transforms reveals the song's ability to evoke strong emotions. The speaker's incapacity to sense love in the "before" stands very opposite from the experience of love in the "after" (Zyga, 2020).

Transition. The line separating absence from presence, from ignorance to consciousness, is the sentence "Till there was you". The word "then" marks the start of a new reality in which the speaker's senses come alive (McCabe, 2013).

Quality of Experience. Words like "wonderful," "sweet," and "dawn" in the "after" photo speak to a pleasant and vivid quality of experience absent in the "before." The wording evokes the story of the song, therefore reflecting its mood. According to Krause (2024), linguistically analyzing the Beatles' albums, notes a change from common communication techniques.

Atmosphere. Language in the "before" points to a drab or subdued environment; language in the "after" conjures freshness, beauty, and joy. The author wakes the senses to love all around by means of the linguistic hues. The listener thus generates the story in the music by arousing their sense and providing them the emotional hue of love (Awuno, 2019). From a state of sensory and emotional absence to one of vivid richness and awareness, "Till There Was You" use opposing language to forcefully show the transforming effect of love.

Love Brings Joy and Harmony. It introduces emotional richness, inner peace, and happiness into the individual's life, often symbolized by "music." The individual's emotional state has been changed from emotional absence to now have emotional richness within. (Perlovsky, 2014)

Love Sharpens Sensory Experience. It increases the individual's ability to perceive and enjoy sensory details like beauty and fragrance. Thus, as demonstrated in the lyrics above, the love enhances the senses and makes it easier to perceive and enjoy the world around them.(Dewaele et al., 2019)

Love Unlocks the Experience of Love. It enables the individual to finally recognize and feel the love that was already present around them. The person has been opened up to love and is now in the position to recognize and experience it(Millán, 2007).

Love is Transformative. It fundamentally changes how the individual interacts with and experiences both the external world and their own internal emotional state, moving from unawareness to vivid perception. The individual experiences a complete change in their experiences with the world due to the effect of love, which opens them up to new ways of feeling and perceiving. This transformation aligns with the concept that love, rather than being a mere emotion, embodies a complex interplay between physiological and spiritual dimensions, impacting individuals on personal and universal levels and fostering moral character development and overall well-being (Murotmusaev et al., 2021)

Overall, "Till There Was You" depicts love as a potent catalyst for personal transformation, awakening senses, enhancing appreciation, bringing joy, sharpening experiences, and ultimately enabling the perception and feeling of love, shifting one from unawareness to vivid awareness.

Specific lines from "Till There Was You" resonate with social norms and expectations of the time:

Incomplete Life Until Romantic Partner: The lines about never hearing the bells until "you" suggest a societal view where romantic love is essential for experiencing life's joys and beauty. The need for a romantic partner to unlock joy can be seen as the societal pressure (Heshmati et al., 2021).

Romantic Partner Opens Eyes to the World: The lines about never seeing the birds until "you" reflect the idea that a romantic partner enriches all aspects of life and perception. This can be seen as the expectation from society of what a partner brings to one's life. (Lesch et al., 2016)

Love Brings Beauty and Sensory Pleasure: The arrival of "you" being linked to "music" and "wonderful roses" aligns with the romantic ideal of love introducing joy and wonder into one's world. The phrase "they tell me", hints at experiencing these through the lens of romantic love. (Kodak & Awino, 2019)

Romantic Love as Key to Experiencing Love: The lines about love being all around but unheard until "you" emphasize romantic love as the primary means of fully experiencing love and fulfillment, potentially overshadowing other forms of love. These lyrics indicate that love functions as a biological reward system, driven by neurochemicals, which encourages individuals to form and maintain relationships (Bamford et al., 2024).

Overall, specific lines in "Till There Was You" reflect social norms of the time by suggesting that a romantic partner is crucial for fully experiencing life's joys, beauty, and even love itself. The lyrics imply that a romantic relationship opens one's eyes to the world's wonders and brings sensory pleasure, aligning with the romantic ideal prevalent during that era.

IV. CONCLUSION

The song "Till There Was You" reveals a powerful portrayal of romantic love as a transformative force that awakens sensory perception, enhances appreciation for the world, and brings profound joy and emotional richness to an individual's life. The song utilizes vivid linguistic color, contrasting a state of sensory and emotional deprivation before love with the vibrant and delightful experiences after its arrival. Furthermore, the lyrics subtly reflect prevailing social norms of the time, suggesting a cultural emphasis on romantic partnership as the key to unlocking life's true beauty, sensory pleasures, and even the experience of love itself.

The phrase "Till there was you" serves as a pivotal point, marking a transition from a muted existence to one filled with vivid sensory and emotional awareness through individual's perception and overall quality of experience.
